



Fig. 1 Vacuum pump V-VGA / V-VGC

4.2 Description

The V-VGA and V-VGC have a fine micro filter on the suction side and on the outlet side an oil and oil mist separator to return the oil to the oil circulation system. The motor fan provides cooling for the motor <u>and</u> pump housing. The motor and the pump have a common shaft.

An integral non-return valve prevents the evacuated system from being ventilated after the pump has stopped and it prevents the feed chamber from being saturated with oil after the system has stopped. This would lead to oil knocking when the system started up again.

A gas ballast valve (an option with V-VGA) prevents condensation of water vapour in the inside of the pump when low amounts of steam are sucked in when the pump is at operating temperature.

4.3. Areas of application

These oil-flooded rotary vane vacuum pumps V-VGA4, V-VGA6, V-VGC4 and V-VGC6 are suitable for creating vacuums. The suction power with unrestricted suction is 4 and 6 m^3 /h at 50 Hz. Data sheets D146/1 (V-VGA) and D147/1 (V-VGC) show the dependency of the suction power on the inlet pressure.

The models are suitable for evacuating closed systems or for a constant vacuum in the following intake pressure ranges:

50 Hz \rightarrow V-VGA: 20 to 500 mbars (abs.) • V-VGC: 2 to 200 mbars (abs.)

60 Hz \rightarrow V-VGA: 20 to 400 mbars (abs.) • V-VGC: 2 to 150 mbars (abs.)

If operated constantly outside these ranges there is the risk of oil leaking through the outlet. When evacuating closed systems the volume to be evacuated must be no more than 2% of the nominal pumping capacity of the vacuum pump.



If the unit is switched on more frequently (at regular intervals of about 10 times an hour) or at higher ambient temperatures and intake temperatures, the excess temperature limit of the motor winding and the bearings may be exceeded.Please contact the manufacturer should the unit be used under such conditions.



If it is installed in the open air the unit must be protected from environmental influences, (e.g. by a protective roof).



- 5 Installation
- 5.1 Preparing for installation

Check the following points:

- Machine freely accessible from all sides
- Do not close ventilation grids and holes
- Sufficient room for installing and removing pipes and for maintenance work, particularly for installing and dismantling the machine
- No external vibration effects
- Do not suck any hot exhaust air from other machines into the cooling system.



The oil filling pointFig. 1/H), oil sight glass (Fig. 1/I) and oil outlet Fig. 1/K) must be easily accessible.

The cooling air inlets (Fig. 1/E) and the cooling air outlets (Fig. 1/F) must be at least 15 cm away from adjacent walls. Cooling air coming out must not be sucked in again. For maintenance work there must be 30 cm in front of the filter (Fig. 1/D) and the oil reservoir cover (Fig. 1/T).

5.2 Installation

NOTICE

The machine may only be operated when it is set up horizontally.

Material damage resulting from the machine tipping over and falling.

When installed at more than 1000 m above sea level a reduction in power is noticeable. In this case we would ask you to contact us

Ensure that the foundation complies with the following conditions:

- Level and straight
- The bearing surface must be at least the same size as the machine
- The bearing surface must be able to bear the weight of the machine



It must be possible to install the machine on a firm foundation without anchoring. When installing on a substructure we recommend fixing with flexible buffers..

- The drive shaft direction of rotation is shown by the rotation direction arrow (Fig. 1/O) on the motor flange.
- a) Start the motor briefly (max. two seconds) to check the direction of rotation. When looking at the motor fan, it must rotate clockwise.

Operating in the wrong direction of rotation leads to damage to the machine.

Use a phase sequence indicator to check the direction of rotation **(anti-clockwise rotating field)**.

This topping up at the filling point (Fig. 1/H) must be repeated until all the oil pipes have been filled completely. The filling point must not be open when the pump is running.

7 Maintenance and repair



DANGER

7.1 Maintenance work




Fig. 3 Air filtering




Fig. 4 Lubrication

If it is not completely emptied the amount that can be refilled is reduced..

The waste oil must be disposed of in compliance with the local environmental protection regulations. If you are going to use another oil type, empty the oil removing device housing and oil cooler completely..

The oil level must be checked at least once a day, if necessary top the oil up to the upper edge of the sight glass (Fig. 4/I) First oil change after 500 hours of operation. Subsequent oil changes after 500 - 2000 hours of operation. Reduce the change intervals accordingly depending on how contaminated the discharged medium is..



Only lubricating oils complying with DIN 51506 group VC/VCL or a synthetic oil approved by Elmo Rietschle must be used. The viscosity of the oil must comply with ISO-VG46 as per DIN51519.*Elmo Rietschle oil types:* MULTI-LUBE46 (mineral oil) and SUPER-LUBE46 (synthetic oil) see also oil recommendation plate (Fig. 4/M)).

If the oil is subject to high temperatures (ambient or intake temperatures over 30°C, insufficient cooling, 60 Hz operation etc.) the oil change interval may be extended by using the recommended synthetic oil.




Fig. 5 Oil removal

The oil separator element may be contaminated with particles of dirt when it has been running for a long time (power consumption and pump temperature increase). We therefore recommend replacing the device every 3,000 operating hours (Fig. 5/L) as it is not possible to clean it.

Reduce the change intervals accordingly depending on how contaminated the discharged medium is. Changing: Undo the screw button (Fig. 5/g). Remove the filter cover (Fig. 5/h). Unscrew the oil reservoir cover (Fig. 5/T). Replace the oil separator element Fig. 5/L). Re-use the O ring (Fig. 5/L₁). Re-assemble in reverse order




Fig. 6 Clearance certificate 7.7025.003.17




Fig. 7 Spare parts list (example))


